


RECENT INSTITUTIONAL ACCOMPLISHMENTS

Assumption teachers and administrators continue to plan for the implementation of Iowa Core Curriculum, which identifies essential skills and concepts in literacy, math, science, social studies, and 21st century living skills. Our math curriculum sequence was modified to provide students a better transition between Algebra I & Algebra II, and the Learning Resource Center and after school study table hours have been increased to help struggling students.

Assumption now offers 16 college credits on campus along with 7 AP classes(English, Biology, Government, US History, Chemistry, Physics, and Calculus). We continue to look for new opportunities to increase both AP and college credit options.

Five electronic whiteboards were installed in classrooms this summer, thanks to a grant from the Scott County Regional Authority. Teachers have been trained on the whiteboards, which will help bring our classroom learning into the 21st century!

One of the most visible facility projects of last fiscal year was the improvement in the appearance of Assumption's front and student entrances. For nearly 50 years the wall behind the statue of Mary at the front entrance was covered in turquoise and brown tile that had cracked and faded over time. That tile was replaced with EIFS (a synthetic stucco), the statue of Mary was refurbished, and the landscaping around the statue was replaced. The result has been a front entrance that is more welcoming and more worthy of our Catholic identity.

At the student entrance, Sunderbruch Auditorium also received a much needed face-lift over the summer. The sheet metal and I-beams outside the auditorium had been exposed to the elements for many years. The weathered I-beams and sheet metal were removed, and new sheet metal and brick were installed in their place.

In addition, parts of the auditorium had occasionally flooded during heavy rains. To address this issue, concrete was removed on the north side of the building and the hill was graded to provide for better drainage. This "fix" created the opportunity to replace the carpet in the auditorium through a grant from the Scott County Regional Authority. Other interior improvements to the auditorium included a partial rewiring and installation of a floor system on top of the new concrete stage. The final result is some wonderful change to a vital facility.

The small gym project, which spanned the entire spring and summer of 2009, was completed with the addition of new bleachers and a scoreboard. These improvements accompanied the new doors, roof, upper interior walls, paint and a new floor. Completion of this project set up a remodel of the small gym locker room, a wonderful enhancement that is now home to our cheerleaders and Knight Kompany Dancers.

We continue to use a comprehensive approach to school improvements, seeking to enhance academics, activities, and facilities. Look for more good reports next year!



2009-2010 SCHOOL YEAR BY THE NUMBERS

- **21%** of the Class of 2010 graduated with a cumulative GPA of **4.0** or higher on a 4.0 scale.
- **51%** percentage of the Class of 2010 graduated with a GPA of **3.5** or higher.
- The average cumulative GPA for the Class of 2010 was **3.356**.
- **89%** of the Class of 2010 took at least one honors, AP, and/or college course.
- **100%** of the Class of 2010 plan to pursue postsecondary education or training. Of these, 97% plan to attend a two or four year institution, and 3% will enter the military or an apprentice program.
- **\$3,342,300** in scholarship money was earned by the Class of 2010.
- **90%** of Assumption junior and senior athletes qualified for MAC All Academic Awards (GPA of 3.25 or above when their sport was in season).
- **100%** of Assumption students participated in community service. The graduating class of 2010 completed over **6,000** hours of service to their school, church, and community organizations during their four years at Assumption.
- AHS students collected **26,640** pounds of food for the Student Food Drive, or 64.8 pounds per student, for an approximate value of \$40,000.





INCOME SUMMARY

GENERAL FUND

July 1, 2009 - June 30, 2010

TUITION AND FEES (\$1,452,514)

Includes tuition for 73 seniors, 122 juniors, 106 sophomores, and 100 freshmen. Tuition was \$4,190 for parish subsidized students and \$5,950 for non-subsidized students. Also included are fees for elementary math, parking permits, graduation, and fines for damaged books.

PARISH SUBSIDY (\$774,545)

Includes commitments from Holy Family, Our Lady of Lourdes, Our Lady of Victory, Sacred Heart, St. Alphonsus, St. Anthony's, St. John Vianney, St. Mary's, and St. Paul the Apostle. Outlying parishes may provide per capita subsidy for students from their parishes.

ANNUAL FUND AND PUBLIC SUPPORT (\$675,495)

Includes April Knight profit of \$126,016 (less \$22,500 reserved for new large gym floor); Annual Fund donations of \$176,654; contributions from the Assumption Foundation of \$31,726; contributions from the Mississippi Valley STO of \$208,717 (tuition assistance); contributions from *Embracing Our Future* of \$151,032 (\$107,723 for tuition assistance, \$38,309 for employee benefits, and \$5,000 for marketing support); and some miscellaneous.

ATHLETICS (\$206,282)

Includes season ticket sales, gate receipts, program advertising, reimbursements from Booster Club (\$21,819) and Century Club (\$14,375), and some miscellaneous.

OTHER (\$183,274)

Includes state transportation reimbursement, Title VI, "Drug Free" money, book store revenue, and interest earned.

RESTRICTED INCOME

Assumption occasionally receives "specified use" gifts. These gifts are held in restricted accounts until they are used for their intended purposes.

GRANTS (\$36,534)

Includes income from the Scott County Regional Authority.


TUITION ASSISTANCE (\$65,615)

WAGES AND BENEFITS (\$2,120,706)

Includes wages of the administrative team, faculty, development staff, support staff, and maintenance staff. Also includes the 7th contribution to the employee 401K plan, a 50% contribution to group health insurance, and FICA.

BUILDINGS AND GROUNDS (\$536,554)

Includes \$6,000 for boiler repairs, \$21,500 for new roof over small gym, \$5,700 towards air conditioning in the band room, \$2,400 for plumbing repairs to underground pipes, in addition to annual expenses for bond issue payments, utilities, cleaning supplies and building repairs. \$202,000 was reserved for future expenses associated with our aging facility.

STUDENT SERVICES (\$64,845)

Includes transportation expenses, testing fees, college counseling expenses, accreditation costs, chapel, and commencement expenses.

INSTRUCTIONAL (\$131,514)

Includes department expenses, teaching supplies, textbooks, and library/media expenses.

INSURANCE AND INTEREST (\$79,777)

Includes liability and unemployment premiums plus interest expense (primarily bond issue).


