RECENT INSTITUTIONAL ACCOMPLISHMENTS

2010-2011 was an exciting year in several ways. Here are a few of the highlights:

The most talked about improvement of the 2010-2011 fiscal year has to be the refurbishing of the large gym. The project began with the generous donation of two new scoreboards in the fall of 2010, and was followed by the replacement of the gym floor over the summer of 2011. Thanks to several generous donors, April Knights '09, '10, & '11, Spaghetti Supper '10, Assumption's Century and Booster Clubs, and a grant from the Bechtel Trust and Foundation, the large gym is the latest object of Assumption pride. On September 13th, Assumption's volleyball teams swept Central in the first home event on the new floor.

With the addition of new technology, including SMART Boards in 18 of our classrooms, we have provided teachers with powerful tools to enhance day to day instruction and maximize the visual learning capacity of students. We continue to develop a cohesive educational strategy that will move Assumption forward, maximizing the educational setting in order to promote a positive climate for teaching and learning.

A new state of the art wireless clock and bell system was installed throughout Assumption in March. The system links our classroom clocks to the bell system, and also ensures that each classroom clock reads the correct time. What may seem like a simple addition has helped make life easier at Assumption.

The 25th annual April Knight, "Wild Wild April Knight," was the most successful in the event's 25 years, raising over \$140,000. A huge thanks to Susie Foster and her tireless group of volunteers for creating such a prosperous and enjoyable evening each year.

Display cabinets that will be home to 50+ years of Assumption memorabilia have been built and installed in Assumption's S-wing. The search for the perfect items to display is still in progress, but we hope to have the cabinets filled by the end of the winter.



2010-2011 SCHOOL YEAR BY THE NUMBERS

- 100% of students, grades 9-12, completed 20 hours of community service.
- 19% of the Class of 2011 graduated with a cumulative GPA of 4.0 or higher on a 4.0 scale.
- 48% of the Class of 2011 graduated with a GPA of 3.5 or higher.
- The average cumulative GPA for the Class of 2011 was 3.405.
- 92% of the Class of 2011 took at least one honors, AP, and/or college course.
- Graduation rate was 100%.
- 100% of the Class of 2011 plan to pursue postsecondary education or training. Of these, 99% plan to attend a two or four year institution, and 1% will enter the military or an apprentice program.
- \$4,537,052 in scholarship money was offered to the Class of 2011.





INCOME SUMMARY

GENERAL FUND

July 1, 2010 - June 30, 2011

TUITION AND FEES ((**\$1,673,263**)

Includes tuition for 118 seniors, 104 juniors, 104 sophomores, and 137 freshmen. Also included are fees for elementary math, parking permits, graduation, and fines for damaged books. Tuition was \$4,315 for parish subsidized students and \$6,130 for non-subsidized students.

PARISH SUBSIDY (**\$767,125**)

Includes commitments from Holy Family, Our Lady of Lourdes, Our Lady of Victory, Sacred Heart, St. Alphonsus, St. Anthony's, St. John Vianney, St. Mary's, and St. Paul the Apostle. Outlying parishes may provide per capita subsidy for students from their parishes.

ANNUAL FUND AND PUBLIC SUPPORT (**\$770,204**)

Includes April Knight profit of \$142,132; Annual Fund donations of \$128,936; contributions from the Assumption Foundation of \$58,730; contributions from Mississippi Valley STO of \$185,936 (tuition assistance); contributions from the *Embracing Our Future* Campaign of \$244,702 (\$199,729 for tuition assistance and \$44,973 for employee benefits) and some miscellaneous. \$315,000 was reserved for future capital needs.


ATHLETICS (**\$191,330**)

WAGES AND BENEFITS (\$2,257,419)

Includes wages of the administrative team, faculty, development staff, support staff, and maintenance staff. Also includes the 8th contribution to the employee 401K plan (up to 3%), a 50% contribution to group health insurance, and FICA.

BUILDINGS AND GROUNDS (\$687,409)

Includes \$5,400 for artificial stucco at the front of the school, \$8,450 for repair of metal siding on the front of the auditorium, \$6,200 for replacement of double glass doors at the end of E wing, and bond issue payments, in addition to annual expenses for utilities, cleaning supplies and building repairs. \$315,000 was reserved for future expenses associated with our aging facility.

STUDENT SERVICES (\$72,068)

Includes transportation expenses, testing fees, college counseling expenses, accreditation costs, chapel, and commencement expenses.

INSTRUCTIONAL (\$184,616)

Includes department expenses, teaching supplies, textbooks, technology and library expenses.

INSURANCE AND INTEREST (\$75,427)

Includes liability and unemployment premiums plus interest expense (primarily bond issue).


