Institutional Accomplishments

We were thrilled to replace the gold, molded plastic seats in the auditorium with cushioned red ones, and capped off that project with upgrades to the auditorium sound system. We also restored the stained glass windows in the chapel with help from the Class of 1982.

The Assumption and St. Ambrose Boards worked toward building a stadium on the former St. Vincent's property, although that process has been slowed by the City of Davenport.

An expansion to our daycare center is serving increasing community demand, and school staff members were trained in the CPR/AED technique following purchase of an AED machine.

Student artists added a mural of the Virgin Mary to the library wall and

heating units were replaced in the band room.

Assumption students participated in a fundraiser that collected over 10,000 diapers for local families in need, and our girls' and boys' basketball teams wore pink jerseys to raise funds for cancer research.

Sophomores had a special experience when Bishop Amos joined them for an eye opening Q & A session. We were blessed to share in Fr. Brodersen's birthday celebration and hear about his experiences as a priest. We also hosted an amazing spiritual experience, our "first ever" ordination, that of Father Chris Young to the transitional diaconate.

Five years ago there were 125 hardwired computers in 4 labs, and our teachers relied on overhead projectors to aid in their visual

displays. We are now a wireless campus with more than 500 computers. Each student and teacher is issued a laptop computer for use during their years at Assumption. Teachers also access 22 electronic whiteboards located throughout the building's classrooms.

We have decreased parish subsidy by 1% for each of the last nine years – at the same time increasing teacher pay, minimizing tuition increases, and retiring the \$1,295,000 bond issue that was issued in 1998!

Last year the Family Tuition Plan provided \$1,156,136 in tuition grants to help 654 K-12 students attend Scott County Catholic schools. This is one big reason Assumption's enrollment is up by more than 100 students over the last several years.

Where does the time go? It seems like we get the school year off to a good start, and before long it's time for Christmas break . . . and a few days later we are making plans for graduation!

I'm not sure that our students would share my perspective, but the days seem to fly by.

Assumption students continue to thrive academically, and the educational opportunities at AHS serve as a great foundation for future success. With increasing hours of college credit now offered on the Assumption campus, 88% of 2014

graduates began college this fall with a head start on freshman year. Several of those were even beginning college at near sophomore status!

As always, the vast majority of our students continue to be engaged in multiple activities – balancing academics with practices and performances, juggling part time jobs with club meetings, and discerning their next steps toward bright futures beyond the walls of high school.

Above all, we are proud of the ways that our students model the faith we profess. Student Hunger Drive, Santa's Knights, Student

Ambassadors, and Blood Drive are just a few of the service opportunities that help keep students grounded. As always, may all that we do please God, and may God continue to watch over the Assumption Family.

A Slice of Student Life

AHS Band students continued to distinguish themselves with seven Division I ratings in solo and ensemble. In addition, ten of our outstanding musicians shared twenty-four honor band selections.

The Knight Players showcased the breadth and depth of their theatrical talents through four outstanding productions. The spring musical, *Children of Eden*, was widely acclaimed by young and old.

The Assumption Choir held its spring concert at Sacred Heart Cathedral, where it presented a newly composed piece by local composer Dave Arnold and a multi-movement work by Mozart that included guest string players and vocal soloists. The choir also received a "1" Superior rating at

the District Large Group Festival for the first time in recent years.

AHS students visited the State Capitol during School Advocacy Days to share information with legislators about the value of nonpublic schools across Iowa.

We held our first ever senior student and parent cookout on the Sunday before school started. Msgr. Parizek offered a blessing for the Class of 2015.

With the state change to district football, Assumption made the decision to compete at 3A. This is commensurate with our enrollment level and affects only football.

For the third consecutive year, and sixth time overall, Assumption won

the Medium School Division (350-799 students) of the Des Moines Register's All-Sports Award. The Knights earned points for state championships in Wrestling, Baseball, Girls' Track & Field, and Girls' Soccer, and for state tournament appearances in Volleyball, Girls' Cross Country, and Girls' Basketball.

We expanded AP course offerings through both in-house and on-line opportunities. At the same time our partnership with Scott Community College continued to expand, with AHS now offering 42 hours of college credit on the AHS campus.







Tuition and Fees

Includes tuition for 114 seniors, 106 juniors, 121 sophomores, and 131 freshmen. Also included are fees for elementary math, parking permits, graduation, and fines for damaged computers. Tuition was \$4,695 for parish subsidized students and \$6,710 for non-subsidized students.

Parish Subsidy

Includes commitments from Holy Family, Our Lady of Lourdes, Our Lady of Victory, Sacred Heart, St. Alphonsus, St. Anthony's, St. John Vianney, St. Mary's, and St. Paul the Apostle. Outlying parishes provided per capita subsidy for students from their parishes.

Annual Fund and Public Support

Includes April Knight profit of \$125,876; Annual Fund donations of \$162,967; contributions from the Assumption Foundation of \$80,935; contributions from Mississippi Valley STO of \$206,528 (tuition assistance); contributions from the Embracing Our Future Campaign of \$221,881 (\$177,500 for tuition assistance and \$44,381 for employee benefits) and some miscellaneous.

Athletics

Includes season ticket sales, gate receipts, program advertising, reimbursements from Booster Club (\$24,200) and Century Club (\$6,200), and some miscellaneous.


Other

Includes daycare center, lunch program, state funding (transportation reimbursement, textbook funds, title funds), rental income, transportation leasing income, and interest earned. This category also includes the usage of funds that were reserved from previous budgets to cover certain expenses of maintaining our facility (see buildings and grounds in Expense Summary).

Wages & Benefits

Includes wages for the administrative team, faculty, development staff, support staff, and maintenance staff. Also includes the 11th contribution to the employee 401K plan (up to 3%), a 50% contribution to group health insurance, and FICA.

Buildings & Grounds

Includes almost \$10,000 for snow removal during the long, harsh winter of 2013-2014, \$3,700 for replacement of the PA system in the school, \$8,400 for expansion of lockers in D wing, \$10,100 for application of sun-filtering film for classroom windows, \$10,700 for repair of stained-glass windows and frames in the chapel, \$13,500 for upgrades to the wireless microphone system in the auditorium and \$245,000 reserved for future expenses associated with our aging facility.

Student Services

Includes transportation expenses, testing fees, college counseling expenses, accreditation costs, chapel, and commencement expenses.

Instructional

Includes \$106,585 for purchase of laptops for all freshmen and sophomores as part of our 1:1 initiative as well as department expenses, teaching supplies, textbooks, other technology, and library expenses.

Insurance & Interest

Includes liability and unemployment premiums plus minimal interest.

Athletics

Includes supplies, equipment, travel, uniforms, officials' fees, field rental, and miscellaneous expenses.

Other

Includes office supplies, postage, advertising, printing, professional fees, and other expenses.


